- 2. <u>General Manager's Report</u>- Kevin Flannery presented the General Manager's report for November 2017. All questions and comments were responded to by Mr. Flannery.

The main explanation is a significant drop in usage of utilities. There has also been an increase in budgeted amount for interest income.
