Lots going on in Mutual 10. In the last few weeks gutters have been cleared, siding has been power-washed and some houses have received replacement roofs (including ours, right now).

If you want to make modifications to your own unit, remember that first you must submit an Application for Building Modification (ABM) form. This is available from our mutual assistant, Shanti Martin, or on the Members, LWMC.com website. Your contractor must provide copies of their permits and licenses and a certificate of insurance. For exterior changes, signatures of approval from your three nearest neighbors are required. This paperwork ensures that the contractor is up to the job and provides a record of the work for the mutual, you and for future occupants of the house.

Rain Rain Go Away ... Come Back

Another Day—yeah, like in August when our gardens and lawns could use a drink. This has been a very wet spring and many flowers and shrubs are looking great. The downside is that the grass has been unruly and some things are looking overgrown. I've seen many residents and landscapers working hard to keep things in check and the results are showing. A couple of reminders, please. Beds should be neat and weed free. Mulch helps with this and also retains moisture for the dry summer months. Also, please

keep an eye on the height of shrubs. Nothing should be above the edge of the roof or in contact with the vinyl siding.

A number of large trees are scheduled for removal in coming weeks. This very large pine (see photo), located along the walking path at the junction with Connecticut Avenue, had reached its end of life. A number of branches, large and small,had dropped during the past 2 years. Also, in the same area a large maple was removed. It had been damaged 2 years ago when strong winds broke off a large limb, hitting a nearby house and causing severe damage. At the time it appeared the tree could be saved, however this spring rotting and a split was detected at the fork of two large sections and the tree had to be removed.



Mutual 10 is fortunate to enjoy a beautiful canopy consisting of a variety of mature trees and it is always a difficult decision to remove a tree. Regular inspections and timely tree trimming will extend this wonderful feature of our neighborhood.

Summary of Leisure World Board of Directors Meeting

April 30, 2024

Community Report:

- Phone System Phase I is complete currently doing the rollout of Phase II of the new phone system.
 Phase III will probably begin in approximately 2 weeks. Also working on the POTS lines to determine the best approach to use for all emergency and elevator phones.
- Transportation Grant Funding This grant was for the purchase of three new buses. We are hoping for funding by September.
- PPD Director Anthony Conerly began on May 13th. We welcome Anthony to the LW Family.
- Administration Building:
- Final utility service connections for Pepco, WSSC, Washington Gas, and Verizon are in progress.
- Curbs, sidewalks and concrete plaza at building entry are completed.
- Approximately 60% of the parking lot has been repaved, including golf parking. Remainder to be repaved after the existing Administration Building demolition and new upper parking lot is completed.
- Building commissioning and start-up testing of all mechanical/electrical equipment to begin 5/28.
- Exterior storefront door openers at upper-level to be installed, allowing for complete removal of construction security fencing.
- Interior furniture delivery scheduled for mid- to late June with occupancy and move to follow in July.
- Once vacated the existing Administration Building will have asbestos abatement followed by demolition and new parking lot construction.
- Overage for construction will be covered by reserves and not the building loan. Pending BOD approval.
- Security: Work has begun to add employee cards and photos to the ID software
- Transportation: Three buses operating as of May 14

Action Items:

- 1. The LW BOD approved the appointment of Dan Linger to Emergency Preparedness Committee.
- 2. The LW BOD approved the appointment of Candy Schimming to Strategic Planning Committee (NOTE: Roger Gerst is moving from member to advisor).

Ways to Stay Informed About Urgent Leisure World and Mutual 10 Matters

Robo Calls: Leisure World and Mutual 10 occasionally use an auto-dial recorded message to convey important and urgent information to mutual residents. Email Paul Eisenhaur (paule@lwm10.com) to be added to the list. Include the desired contact phone number.

Leisure World Management Emails: To receive information/notifications from Leisure World management, go to your profile on the Mutual 10 website (www.lwm10.com). Go to residents.lwmc.com and sign up near the bottom of the Sign-Up page.

Electric Vehicle Charging

If you plan to charge an electric vehicle (EV) at your home, you must complete an "Application for EV Charger" form and submit it to the Mutual Assistant prior to charging your EV. A form is available from the Mutual Assistant. Once the EV charger has been installed you will need to pay for the power it uses at the rates stated on the form.

At this time, checks should be made payable to "Maryland Mutual No. Ten" and delivered to Shanti Martin, our Mutual Assistant, at the beginning of each month. If you have previously registered an EV and have not been paying the monthly fee, please contact Shanti and begin making payments now.

These reminders have been in place, unchanged, for a couple of years. I think it's time for a change. Below is a quick summation of the things we, as a mutual, find important to remember as we go about our busy lives. And then I've added what I think is really important, no matter where we live or who we are. That will follow this summation.

- Pets. Keep them on a leash, pick up their leavings, and don't let them make too much noise.
- Wildlife. Don't feed them.
- **Outside Decorations.** Don't attach them with screws, nails, or anything destructive.
- Garbage/Recyclling. Put trash cans and/or recycling bins out for Monday and Thursday pickup (garbage and metal/plastic/glass). Paper/cardboard goes out for Wednesday pickup..
- Yard Debris. BY REQUEST ONLY on Monday and Thursday. Call the Grounds Department (301-598-1314) to notify them you have yard debris for pick-up. Use the tall, brown paper yard-recycling bags and place them near the street.
